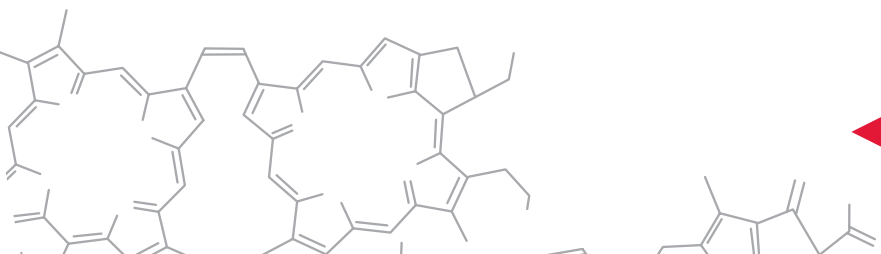
- Perishable, stored products can attract pests like the beetle, weevil and mealworm species.
